- 3 properties; to provide for related matters; to provide an effective date; to repeal conflicting
- 4 laws; and for other purposes.

6 SECTION 1.

- 7 An Act to repeal and replace the charter of the Town of Tyrone, in Fayette County, approved
- 8 April 17, 1975 (Ga. L. 1975, p. 3876), as amended, is amended by adding a new subsection
- 9 to Section 1.103 to read as follows:
- 10 "(c) Notwithstanding any other provision of this charter to the contrary, the corporate
- limits of the Town of Tyrone shall not include any of the following described property:
- 12 ALL THAT CERTAIN TRACT OR PARCEL OF LAND LYING AND BEING IN
- LAND LOTS 154, 155, 167 & 168, 7TH LAND DISTRICT, TOWN OF TYRONE,
- 14 FAYETTE COUNTY, GEORGIA AND BEING MORE PARTICULARLY
- 15 DESCRIBED AS FOLLOWS:
